



Tax Revenues of Kaohsiung city - Total


Tax Revenues of Kaohsiung city - Land Value Tax


Tax Revenues of Kaohsiung city - Land Value Increment Tax


Tax Revenues of Kaohsiung city -House Tax


Tax Revenues of Kaohsiung city -Vehicle License Tax


Tax Revenues of Kaohsiung city - Deed Tax


Tax Revenues of Kaohsiung city - Stamp Tax


Tax Revenues of Kaohsiung city - Amusement Tax
